ORDER

THIS MOTION for an Order in respect of administrative matters under the settlement agreement between the Plaintiffs and the Defendant dated September 15, 2021 (the "**Settlement**")

Agreement”), was heard in writing. Capitalized terms used in this Order have the same meaning as in the Settlement Agreement unless otherwise defined.

ON READING the motion record of the Representative Plaintiffs and the Defendants (together, the “**Parties**”)

1. **THIS COURT ORDERS:**

- (a) The appointment of Cheyenna Hunt and Katrina Maurice as members of the First Nation Advisory Committee;
- (b) The approval of the Administrator’s proposed Oversubscribed First Nations’ Protocol, in accordance with ss. 3.02(a) and 7.02(1) of the Settlement Agreement;
- (c) The Administrator to implement the Protocol for adult persons under disability who may not have appointed persons to manager their property/finances, which would allow the Administrator to accept, (i) proof of their current participation in a provincial disability support program, (ii) a letter or record from a healthcare professional stating the claimant is a person under disability, or (iii) letters from a First Nation’s Chief, Band Council, a member of the First Nation’s Health Department or a Band Administrator regarding the appointment of a representative of persons under disability, and direct payment in accordance with s. 13.03 and ss. 7.01(1) of the Settlement Agreement;
- (d) The Administrator to pay into the Manitoba Court of King’s Bench any amounts under the Settlement Agreement that the Administrator determines are due to minor Class members residing either outside of Canada or in the Territories; and
- (e) The approval and direction of payment of legal fees and disbursements totalling \$140,792.45 inclusive of taxes, for ongoing legal services rendered by Class Counsel and the Joint Committee for Q4 2024 in accordance with ss. 18.02(2) and (4) and 15.01(8) of the Settlement Agreement, which fees are to be paid out of funds currently held by Class Counsel for this purpose.

2. **THIS COURT ORDERS THAT** there shall be no costs of the within motion.
